**OPERATION DETAILS**


- The LLFM is organized and managed by Friessen Development, Inc. Generally, FDI representatives will staff every market to share information about the development and assist with set-up. FDI reserves the right to delete or modify its policies, procedures, rules and regulations. All vendors must be approved by FDI.
- The Lake Lorraine Farmers Market is located on the EAST side of the development in the parking lot between Hobby Lobby and Dave & Buster’s. Part of the parking lot will be blocked off to vehicular traffic to promote safety for all vendors and customers. FDI reserves the right to change or adjust the market location at any time if needed due to construction around the development.
- The market runs every Thursday, beginning the first Thursday in June and running into October (final date TBD and based on weather). Hours are 4-7 p.m. through September. Beginning the first October market date, hours adjust to 4-6:30 p.m. Vendors may arrive and be at their selling space 60 minutes prior to opening and should be ready sell 10 minutes before the market opens. Vendors are expected to attend the market day for its entirety unless there are extenuating circumstances.
- Electricity is available from a retail building. The Vendor is responsible for bringing electrical cords to connect. If you have a quiet generator, you can use that.

**LLFM VENDOR CODE OF CONDUCT:**

This code of conduct is to be followed in addition to the LLFM vendor rules and regulations. The activities outlined below are strictly prohibited. Any individual who violates this Code is subject to discipline, up to and including removal from the market.

- Abusive language.
- Possession or use of alcoholic beverages or illegal drugs at LLFM event or reporting to the market while under the influence of drugs or alcohol.
- Bringing dangerous or unauthorized materials such as explosives, firearms, weapons or other similar items to a LLFM event.
- Discourtesy or rudeness.
- Verbal, physical or visual harassment.
- Actual or threatened violence toward any individual or group.
- Conduct endangering the life, safety, health or well-being of others.
- Failure to follow any agency policy or procedure.
- Bullying or taking unfair advantage of any participant.
- Failure to act in the best interest of the LLFM.
